1. The engagement is purely on a part-time and contractual basis. It shall not confer any right for regular appointment or continuity in service.

4. The consolidated remuneration shall not be more than Rs. 40,000/- (Rupees Forty Thousand only) per month (all inclusive) subject to annual revision of not more than 5% on the base value for upto 03 years' maximum.
